

2024 American Express Shop Small[™] Amex Offers Terms and Conditions

- 1. An Eligible American Express[®] Card is entitled to receive the Registered Card Offer at up to three different Participating Merchant physical locations during the Promotion Period, with a limit of one HK\$10 statement credit per Participating Merchant physical location, up to a total of HK\$30 statement credit.
- 2. The registration period commences on July 1, 2024 and ends on September 30, 2024, both dates inclusive ("Promotion Period").
- 3. Cardmembers must successfully register an Eligible Card during the Promotion Period, then spend a net amount of HK\$50 or more, in one transaction ("Spending Requirement") in-person at participating Shop Small locations in Hong Kong ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$10 back in statement credit ("Registered Card Offer"). - 4. The Registered Card Offer is open to individuals who hold Basic and/or Supplementary American Express Cards issued by American Express International, Inc.
