



2024 American Express Shop Small™ Amex Offers Terms and Conditions

1. An Eligible American Express® Card is entitled to receive the Registered Card Offer at up to three different Participating Merchant physical locations during the Promotion Period, with a limit of one HK\$10 statement credit per Participating Merchant physical location, up to a total of HK\$30 statement credit.
2. The registration period commences on July 1, 2024 and ends on September 30, 2024, both dates inclusive ("Promotion Period").
3. Cardmembers must successfully register an Eligible Card during the Promotion Period, then spend a net amount of HK\$50 or more, in one transaction ("Spending Requirement") in-person at participating Shop Small locations in Hong Kong ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$10 back in statement credit ("Registered Card Offer"). 4. The Registered Card Offer is open to individuals who hold Basic and/or Supplementary American Express Cards issued by American Express International, Inc. ("American Express") in Hong Kong ("Eligible Cards"), excluding American Express® Corporate Cards and Cards bearing the American Express name, brand or logo issued by partners of American Express.
5. The Registered Card Offer is only available for the Cardmember's selected Card, and other Cards held by the Cardmember may not be eligible.
